WHEREAS, the County purchases burial lots within this designated space, and

WHEREAS, the New York State Department of State has made \$10,000.00 available to the County to be used for the purchase of additional burial lots, and

WHEREAS, the Governmental Services and Administration Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed such request with a majority of the members voting approval, now, therefore, be it

RESOLVED, the Chairman of the Ulster County Legislature is hereby authorized to execute a contract, and any amendments thereto, with the New York State Department of State to accept \$10,000.00 to be used for the purchase of burial lots in the Ulster County Veterans Cemetery, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney,
