WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Information Services, and

WHEREAS, the Director of Ulster County Information Services has been informed by the New York State Department of Education that the County was awarded a Local Government Records Management Grant (Project No. 0580-12-2394), on November 23, 2011, for the period beginning July 7, 2011 and ending June 30, 2012, in the amount of \$38,850.00 to perform a comprehensive review of the County's vital records, and create a disaster management plan for the County, and

WHEREAS, the grant will contract out services to be used to engage a consultant who will identify the County's vital records, develop procedures to mitigate the risk of loss of records, institute procedures that will enable the County to recover from a disaster or other interruption of normal business operations, develop a continuity plan, and identify relevant technologies for implementation; these steps will foster the implementation of a County records disaster management plan, and

WHEREAS, the project will reduce the possibility of permanent loss of public documents and provide disaster recovery services, and

WHEREAS, this funding is 100% State funds, and requires no matching County contribution, and

WHEREAS, the Director of Information Services requests the 2012 Ulster County Budget be amended to increase the Department of Information Services State Aid revenue by \$38,850.00 and to provide appropriations in the amount of \$38,850.00 for contractual services to complete the project, and

WHEREAS, the Environmental, Energy and Technology Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it
