WHEREAS, the Director of the Ulster County Office of Employment and Training has been notified that its allocation for the 2012 Summer Youth Employment Program (SYEP) is \$188,924.00 which includes an increase of \$74,832.00 over the previously budgeted amount; and

WHEREAS, the SYEP is 100% funded through the New York State Office of Temporary and Disability Assistance; and

WHEREAS, the additional funding will be used to serve more young people throughout Ulster County and to hire an additional temporary seasonal worker to administer the SYEP for the three months it is in operation; and

WHEREAS, the County Executive and the Director of the Ulster County Office of Employment and Training requests the 2012 Ulster County Budget be amended to reflect the additional revenue and provision of services for the 2012 SYEP; now, therefore, be it
