

Authorizing The Chairman Of The Ulster County Legislature To Execute An Intermunicipal Agreement For The Coordinated Children's Services School Placement Preventive Program With Ulster County Board Of Cooperative Educational Services (BOCES) – Department Of Social Services

The Health and Human Services Committee (Chairman Frey and Legislators Harris, Maio, Petit, Ronk, Briggs, Loughran, Parete, and Stoeckeler) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Social Services, and

WHEREAS, Section A3-4 (Y) and A2-6(A)(3) the Administrative Code provide that the Chairman of the Ulster County Legislature can, upon approval of the County Legislature, execute an intermunicipal agreement on behalf of the County of Ulster, and

WHEREAS, pursuant to General Municipal Law, Section 119-n(a), the definition of a municipal corporation includes a board of cooperative educational services, and

WHEREAS, the Commissioner of the Ulster County Department of Social Services requests that the Chairman of the Ulster County Legislature be authorized to execute an Intermunicipal Agreement with Ulster County Board Of Cooperative Educational Services (BOCES) in the amount of \$5,750.00 for the Coordinated Children's Services School Placement Preventive Program, for the term January 1, 2012 through December 31, 2012, and

WHEREAS, the Coordinated Children's Services School Placement Preventive Program will enroll fifteen high-risk students in the Ulster County BOCES after school program, and who will be overseen by a case aide who will organize after school activities, assist the students on a daily basis and in times of crisis, meet with their families, and facilitate collaboration with school and community service providers, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an Intermunicipal Agreement, and any amendments thereto, with Ulster County BOCES in the amount of \$5,750.00 for the Coordinated Children's Services School Placement Preventive Program, for the term January 1,
