WHEREAS, the Ulster County Mental Health Department has been informed by the NYS Labor Department that 10-month employees are eligible for unemployment benefits, and

WHEREAS, the FACETS (Family and Child Early Treatment Services) Program, a school-based clinical treatment program, has been structured upon a model where services are primarily provided in accordance with the school calendar (10 months), and

WHEREAS, Ulster County would have to increase its contribution for the program to pay for unemployment expenses if the program were maintained as a 10-month program, and

WHEREAS, in order to avoid these costs Ulster County Mental Health Department has proposed that all employees in the program be made 12-month employees and that the additional costs be offset with voluntary furlough or revenues generated from billable services by those employees who choose to work 12 months, and

WHEREAS, there is no increased cost to the County as a result of this transaction, and

WHEREAS, the Health Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Personnel Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
