WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Sheriff, and

WHEREAS, the Ulster County Sheriff's Department, in the normal course of performing its duties, participated in a search/rescue/recovery operation involving the crash of a small plane into the Hudson River, and

WHEREAS, in the course of the operation some of the equipment belonging to the Sheriff's Department Dive Team, which was essential to the operation, was damaged beyond repair, and

WHEREAS, the Ulster County Sheriff's Department equipment, which was damaged beyond repair and no longer usable, was covered under an insurance policy, and

WHEREAS, the insurance payment of \$33,270.60 has been received from the insurance carrier, and

WHEREAS, the Ulster County Sheriff's Office now requests that the 2011 Ulster County Budget be amended to appropriate the \$33,270.60 recovery to replace the equipment damaged in the search/rescue/recovery operation, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it
