Authorizing The Chairman Of The Ulster County Legislature To Execute A Revised Lease Agreement With Tivoli Management Corporation For The Mental Health Satellite Office In Highland – Department Of Public Works (Buildings And Grounds)

The Public Works and Capital Projects Committee (Chairman Fabiano and Legislators Felicello, Maloney, Roberts, Hochberg, Loughran and Provenzano) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works, and

WHEREAS, the lease agreement with Tivoli Management Corporation for the Ulster County Department of Mental Health satellite office, at 560 Rt. 299, Highland, New York, expired on May 31, 2010, and

WHEREAS, the Ulster County Legislature, by the adoption of Resolution No. 140, dated May 18, 2010, authorized the Chairman to execute a lease with Tivoli Management Corporation for the continued use of the office space for a term of three years, commencing June 1, 2010 and ending May 31, 2013, at an annual rent of \$37,200.00, with no increase from the previous five-year lease, and

WHEREAS, pursuant to Resolution No. 140, the office space was stated as 3,800 square feet, which amounted to a rental rate of \$9.79 per square foot, and

WHEREAS, as a result of a ministerial error, the number of square feet and, as a consequence, the price per square foot, were misstated in Resolution No. 140 and in the lease agreement, and

WHEREAS, the correct number of square feet is 3,432, making the correct price per square foot \$10.84, and

WHEREAS, the actual space occupied by the County remains unchanged and the annual rent remains unchanged from the previous lease, that is, \$37,200 annually, and

WHEREAS, the tenant, the County of Ulster, shall have the option to terminate the lease for any or no reason, upon ninety days written notice to the landlord, and

WHEREAS, the Commissioner of Public Works has requested that the Chairman of the Ulster County Legislature be authorized to execute a revised lease with Tivoli Management Corporation for the continued use of the office space for a term of three years, commencing September 1, 2010 and ending August 31, 2013, at an annual rent of \$37,200.00, for 3,432 square feet or \$10.84 per square foot, and
