The Law Enforcement and Public Safety Committee (Chairman Hayes, and Legislators Belfiglio, Ronk, Sweeney, Briggs, Hochberg, and Rodriguez) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Sheriff, and

WHEREAS, the Ulster County Sheriff's Office participated in "Operation Small Fry" which had as an objective the prevention of terrorist attacks by enhancing law enforcement's capability to support international border and waterway security by disrupting and deterring criminal activity, and

WHEREAS, the Ulster County Sheriff's Office participation in this operation is important to help promote homeland security by, among other objectives, collecting data on the movement of foreign-flagged vessels, which data is then communicated to the United States Coast Guard, and

WHEREAS, the Ulster County Sheriff is requesting that the Chairman of the Ulster County Legislature be authorized to execute an agreement with the New York State Division of Homeland Security and Emergency Services, for the period June 1, 2011 through June 30, 2011, in the amount of \$2,874.00 to reimburse the Ulster County Sheriff's Office the cost of overtime associated with "Operation Small Fry," and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement, and any amendments thereto, with the New York State Division Of Homeland Security and Emergency Services for overtime reimbursement in the amount of \$2,874.00, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and, be it further
