WHEREAS, Operation IMPACT VII is an expanded crime reduction program related to criminal activity identified as drug use and gang violence, and will involve the Ulster County Offices of the County Sheriff, District Attorney, and Probation, at an approximate cost of \$189,331.00,and

WHEREAS, each County dollar spent under the Operation IMPACT VII initiative is 100% reimbursable by the New York State Division of Criminal Justice Services, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Governmental Services, Environmental and Administrative Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
