In Support Of New York State Assembly Bill No. A2281 And New York State Senate Bill No. S2494 Authorizing The New York State Legislature To Require A State Or Municipal Entity To Enact A Period Of Residency Requirement For Persons Applying For Certain Social Services

Legislators Madsen and Ronk offer the following:

WHEREAS, it is well documented that State-mandated public assistance programs have become a hot-button issue, and

WHEREAS, the 2011 – 2012 State Budget cuts impose an increase to the burden on counties for certain Social Services programs, and

WHEREAS, a concurrent resolution, New York State Assembly Bill No. A2281 and New York State Senate Bill No. S2494 authorizing the New York State Legislature to require a state or municipal entity to enact a period of residency requirement for persons applying for certain social services, and

WHEREAS, New York State Assembly Bill No. A2281 and New York State Senate Bill No. S2494 proposes an amendment to article 17 of the constitution, in relation to a residency period prior to receipt of certain social services:

Section 1. Resolved (if the Senate concur), That article 17 of the constitution be amended by adding a new section 8 to read as follows:

- S 8. NOTWITHSTANDING ANY OTHER PROVISION OF THIS CONSTITUTION, THE LEGISLATURE MAY DIRECT THE STATE, A MUNICIPALITY OR OTHER ENTITY ACTING AS AN INSTRUMENTALITY OF THE SATE OR A MUNICIPALITY, TO REQUIRE A SPECIFIC PERIOD OF RESIDENCY WITHIN THE STATE AS A PREREQUISITE TO ANY PERSON SEEKING THE PROVISION OF SUCH SERVICES SET FORTH IN THIS ARTICLE.
- S 2. Resolved (if the Senate concur), That the foregoing amendment be referred to the first regular legislative session convening after the next succeeding general election of members of the assembly, and, in conformity with section 1 of article 19 of the constitution, be published for 3 months previous to the time of such election, and

WHEREAS, the proposed legislation would provide important relief to the people of Ulster County, now, therefore, be it
