WHEREAS, the County's lease with Heritage Oil Service, Inc. for the Family Court premises (including the Public Defender's Office space and Consumer Fraud office space) expires August 31, 2009, and

WHEREAS, the Commissioner of Public Works is requesting that the Chairman of the Ulster County Legislature be authorized to execute a renewal of the lease agreement for Family Court for a five (5) year period commencing September 1, 2009 through August 31, 2014, and

WHEREAS, G.D. Realty Company (Owner) and Heritage Oil Service, Inc. (Lessee) have agreed to a ten percent (10%) reduction from the previous annual base rent of \$224,000.00, to a new annual base rental of \$201,600.00, and

WHEREAS, the Public Works Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute a renewal of the lease agreement with G.D. Realty Company (Owner) and Heritage Oil Service, Inc. (Lessee) for the Family Court premises (including the Public defender's Office space and consumer Fraud office space) for a five (5) year period commencing September 1, 2009 through August 31, 2014, at a ten percent (10%) reduction from the previous annual base rent of \$224,000.00, to a new annual base rental of \$201,600.00, in the form as shall be filed with the Clerk of the Ulster County Legislature or as may be modified with the approval of the County Attorney,
