WHEREAS, an agreement entered into an agreement between the State of New York, acting by and through the Department of Social Services for a period of five years, ending September 30, 2011, (Contract No. C060056) (the "Contract") for the provision of the Long Term Care Point of Entry (NY Connects) Program (the "Program"), and

WHEREAS, beginning year six, effective October 1, 2011, NY Connects Program funding will be allocated rather than contracted to each County's Area Agency on Aging (AAA) by the New York State Office for the Aging, in collaboration with the Ulster County Office for the Aging and Ulster County Department of Social Services, for the program year October 1, 2011 to September 30, 2012, and

WHEREAS, Ulster County's allocation for the program year is \$58,650.00 which will be received to reimburse the County for Program expenditures incurred by the Ulster County Department for the Aging for salaries, benefits, and contractual costs, after summiting an Application, Standard Assurances, Program Narratives and Program budget, and

WHEREAS, the goal of the Program is to insure that each County Area Agency on Aging will provide improvements to senior consumers thru planning and improving access in the long term care needs of the residents such as efficient services for homecare, institutional care, transportation, housing, and home delivered meals, of the County, and

WHEREAS, the Director of the Ulster County Office for the Aging requests the Chairman of the Ulster County Legislature to execute the Program Application on behalf of the Ulster County Office for the Aging, and
