WHEREAS, each year there is a staggering 95 percent mortality rate for over 300,000 Americans who are victims of sudden cardiac arrest; in an effort to save lives, in March 2008, a task force was created to implement a Heart Safe Program in Ulster County, and

WHEREAS, the Heart Safe Program Task Force has worked with the American Heart Association which has recognized the need for more public participation in CPR training and public access and training on defibrillators, and

WHEREAS, efforts continue to expand the number of automatic external defibrillators and increase the number of certified CPR/AED responders throughout the County, and

WHEREAS, the New York State Legislature has notified the County of Ulster of a Legislative Grant in the amount of \$5,000.00 which will be used to purchase additional AED's for various County occupied buildings, and

WHEREAS, this grant requires no matching funds from Ulster County, and

WHEREAS, the Health Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement to accept a Legislative Grant in the amount of \$5,000.00 to purchase additional AED's for various County occupied buildings, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and, be it further
