WHEREAS, this resolution was submitted by the County Executive on behalf of the Department of Public Works (Buildings and Grounds), and

WHEREAS, the Ulster County Department of Health is consolidating leases for clinics in order to achieve more efficient use of space and to save money, and

WHEREAS, as part of this reorganization, the Department of Health has been seeking office/clinic space for the relocation of its Women, Infants and Children (WIC) Program from New Paltz to Kingston to better serve individuals in need of WIC services, and

WHEREAS, the Department of Health has also been seeking to consolidate its services for sexually transmitted diseases into one office space, and

WHEREAS, 2,917 square feet of office space is available at Willow Park Office Complex, Suites 230 and 250, Aaron Court, Kingston, New York, at a cost of \$11.75 per square foot or \$34,274.75 annually, with all utilities and taxes included, and

WHEREAS, this office space would house the WIC program and offer clinical services for sexually transmitted diseases, and

WHEREAS, the Commissioner of Public Works has requested that the Chairman Of The Ulster County Legislature be authorized to execute a lease agreement with Willow Park, Inc., for a term of three years from November 1, 2010 through October 31, 2013, at an annual rental cost of \$34,274.75, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of the members voting approval, and

RESOLVED, that the Chairman Of The Ulster County Legislature is hereby authorized to execute a lease agreement with Willow Park, Inc. for 2,917 square feet of office/clinic space at Willow Park Office Complex, Suites 230 and 250, Aaron Court, Kingston, New York, for a three-year period from November 1, 2010 through October 31, 2013, at an annual rental cost of \$34,274.75, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and be it further

RESOLVED, the tenant, the County of Ulster, shall have the option to terminate the lease for any or no reason, upon sixty days written notice to the landlord,

and move its adoption.
