The Health and Human Services Committee (Chairman Frey and Legislators Harris, Ronk, Petit, Briggs, Loughran, Parate and Stoeckler) and Co-Sponsors: The Public Works and Capital Projects Committee (Chairman Fabiano and Legislators Felicello, Maloney, Roberts, Hochberg, Loughran and Provenzano) offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Social Services and the Department of Public Works, and

WHEREAS, the Commissioner of Social Services and the Commissioner of Public Works request that the Chairman of the Ulster County Legislature be authorized to execute a lease agreement with the American National Red Cross, for office space at 21 O'Neil Street, Kingston, New York, to provide a location for a Child and Family Advocacy Center, and

WHEREAS, the term of the lease will be for five years, commencing November 1, 2011 through October 31, 2016 for an annual cost of \$21,600.00 for 2,400 square feet at the cost of \$9.00 per square foot; for a five-year cost of \$108,000.00, which will be funded by the New York State Office of Children and Family Services (OCFS), Grant No. C025524, and

WHEREAS, the Commissioner of Social Services intends to initiate the formation of a Child and Family Advocacy Center for the purpose of providing a neutral, family friendly site to provide multiple discipline services to child victims of sexual and physical abuse, and child and adult victims of domestic violence, and

WHEREAS, the establishment of this neutral site will enable the Ulster County Family Violence Unit (FVU) to achieve Tier 1 status, which will qualify FVU for increased funding through the OCFS, and

WHEREAS, the Commissioner of Social Services requests that the Legislature authorize the execution of the five-year lease agreement, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of the members voting approval, and

and move its adoption.
