Resolution No. 234 September 21, 2010

Urging United States Congress To Equalize The Medicare Reimbursement For Hospitals In Ulster And Dutchess Counties

The Health and Human Services Committee (Chairman Frey and Legislators Harris, Petit, Ronk, Briggs, Robert Parete and Stoeckeler) offers the following:

WHEREAS, in a recent report from the HealthAlliance of the Hudson Valley (Benedictine Hospital and the Kingston Hospital), as of September 2009, they report the following:

- Average wages in Ulster County hospitals have fallen below 85% of peer hospital wages;
- Hospital workers in Ulster County have not received wage increases in two years;
- Due to the years of inequity, salaries in Ulster County have fallen below the threshold to remain in the Poughkeepsie/Newburgh MSA;
- Ulster County hospitals are economically disadvantaged while surrounding hospitals in adjoining counties are experiencing significant gains;
- Ulster County hospitals have an extremely difficult time recruiting and retaining nurses;
- Ulster County hospitals are performing the same procedures as in adjacent counties and receiving significantly different reimbursement (in many cases, these procedures are performed by exactly the same physicians); and

WHEREAS, Ulster and Dutchess Counties are equidistant from the New York City metropolitan area and should be reimbursed at the same rate as Dutchess County hospitals, and

WHEREAS, the people of Ulster County are losing \$10 million per year with the current lower Medicare Hospital Reimbursement, and

WHEREAS, this is unfair for the healthcare and economic situation of Ulster County residents, now, therefore, be it

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Ulster County Legislature as representatives of the people of Ulster County urge the United States Congress to equalize the Medicare Reimbursement for hospitals in Ulster and Dutchess Counties, and, be it further
