WHEREAS, this resolution has been submitted by the County Executive on behalf of the Director of the Office of Employment and Training; and

WHEREAS, the Director of the Ulster County Office of Employment and Training has been notified that its grant application for the purchase of various pieces of assistive technology equipment has been approved by the New York State Department of Labor in the amount of \$8,694.27; and

WHEREAS, the grant is 100% funded through the New York State Department of Labor and requires no matching County funds; and

WHEREAS, the funds will be used to purchase equipment that will assist disabled customers of the Ulster Works OneStop Center, including high magnification computer monitors, text to speech conversion software and a wheelchair-accessible computer station ; and

WHEREAS, the County Executive and the Director of the Ulster County Office of Employment and Training request the 2012 Ulster County Budget be amended to reflect the additional revenue and appropriations; now, therefore, be it
