

**Establishing Capital Project No. 315 For The Purchase Of Vehicles For Various County Departments For The Year 2009 – Amending The 2009 Ulster County Capital Project Fund Budget**

The Ways and Means Committee (Chairman Lomita, and Legislators Cahill, Dart, Gregorious, Provenzano, Zimet, Cummings, Gerentine and Noonan) offers the following:

WHEREAS, the Ulster County Legislature adopted the Capital Program for the Years 2009 to 2014 which included the recommendation to purchase eleven vehicles at a cost of \$299,300.00 to supplement the aging fleet of existing vehicles, and

WHEREAS, the County Executive requests a capital project to be established and funded to purchase eleven vehicles at a cost of \$299,300.00, and

WHEREAS, the recommended purchases include one ¾ ton pick up truck for Weights and Measures (\$18,300.00), one sedan for Purchasing (Social Services - \$18,000.00), one pick up truck for Buildings and Grounds (\$19,000.00), one van for Information Services (\$20,000.00), six marked patrol cars and one SUV for the Sheriff (\$224,000.00), for a total cost of \$299,300.00, and

WHEREAS, the vehicles purchased will replace vehicles that have high mileage or have been damaged beyond reasonable repair and have been determined to be unsafe, and

WHEREAS, the vehicles which have been replaced will be inspected and repaired, if feasible, and if in reasonably safe condition, will be transferred to other County agencies, thereby reducing the County’s Fleet purchase costs, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the 2009 Ulster County Capital Fund Budget is hereby amended as follows:
