WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Purchasing (Central Services), and

WHEREAS, during the course of the year the costs of postage will exceed the amount of \$200,000.00 that was adopted in the 2011 General Fund Budget, and

WHEREAS, the cost of postage for the year is higher than the budgeted amount due to increased mailings required by legislative redistricting, which totaled \$37,481.22 and was not included in the Board of Elections budget, and the forthcoming large mailing of delinquent tax bills, along with normal mailing activity, and

WHEREAS, the Department of Planning's "fees for professional services" account was funded in the amount of \$50,000.00 for the purpose of covering expenses associated with redistricting, and there remains a balance of \$34,760.00, and

WHEREAS, the Director of Purchasing requests a transfer from the Department of Planning "fees for professional services" account, with the consent of the Director of Planning, in the amount of \$34,760.00 to the Department of Purchasing, Central Services postage account in order to cover the costs of mailings to year end, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
