

Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement And Any Amendments To The Agreement With Ulster County BOCES To Provide Computer Information Technology Education Services To County Employee Workforce – Information Services

The Administrative Services Committee (Chairman Provenzano and Legislators Hochberg, Lomita, Terpening, Hansut, Petit and Ronk) offers the following:

WHEREAS, the Director of Information Services has requested that the Chairman of the Ulster County Legislature be authorized to execute an agreement and any amendments to the agreement with Ulster County BOCES to provide computer information technology education services to the County employee workforce for the period beginning July 1, 2009 and ending June 30, 2010, and

WHEREAS, New York State's General Municipal Law Article 5-G, Section 119-o (1) and Section A3-4 (Y) of the Ulster County Administration Code provides that the Chairman of the Ulster County Legislature, when supported by a resolution, can enter into an inter-municipal agreement of behalf of the County of Ulster, and

WHEREAS, pursuant to General Municipal Law, Section 119-n(a), the definition of a municipality includes a board of cooperative educational services, and

WHEREAS, the Director of Information Services has requested that a agreement be approved with Ulster County BOCES in the amount of \$25,500.00; the 2009-2010 training estimate is approximately three-hundred (300) hours of Onsite Education at a rate of eighty-five dollars (\$85.00) per Training Hour, and

WHEREAS, the purpose of this agreement will provide computer information technology education services for the County employee workforce, and

WHEREAS, Ulster County BOCES will provide on an as-needed basis, education and training instructors for the County training sessions to be held at the Ulster County Information Services Classroom, located at 25 South Manor Avenue, Kingston, New York, 12401, for the term of this agreement July 1, 2009 and ending June 30, 2010, and

WHEREAS, Ulster County BOCES will provide a report detailing the training sessions and provide the number and names of attendees, the number of hours of instruction, and which classes were the subject of the training sessions, and

WHEREAS, Ulster County Information Services will inform Ulster County BOCES at least one (1) week in advance of the class, that an instructor is required; the County will inform the Ulster County BOCES at least one week prior to the established class date, of any and all cancellations of class due to inadequate number of COUNTY employees signed up for class, (less than seven [7]), and

WHEREAS, the course content is to be agreed upon by the County and Ulster County BOCES, with the following typical education offered to include:

Introduction to PC/Windows
Introduction to MS Access 2003 Part I and II
Intermediate MS Access 2003 Part I and II
Advanced MS Access 2003
Introduction to MS Excel 2003 Part I and II
Intermediate MS Excel 2003 Part I and II
Advanced MS Excel 2003
Introduction to MS Word 2003 Part I and II
Intermediate MS Word 2003 Part I and II
Advanced MS Word 2003
MS PowerPoint 2003 Part I and II

WHEREAS, the funding for this agreement has been approved in the Ulster County 2009 Budget, and

WHEREAS, the Administrative Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement and any amendments to the agreement with Ulster County BOCES in the amount of \$25,500.00, to provide computer information technology to the County employee workforce for the period beginning July 1, 2009 and ending June 30, 2010, and, be it further
