The Economic Development and Tourism Committee (Chairman Maloney and Legislators Aiello, Frey, Hayes, Sweeney, Terrizzi, Donaldson, Loughran and Rodriguez) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Department of Public Transportation, and

WHEREAS, four capital projects: building upgrade at \$450,000.00; fuel storage at \$175,000.00; bus purchases at \$1,470,006.00; and automatic vehicle locators at \$440,000.00, were established and funded with Federal Transit Funds through the American Recovery and Reinvestment Act (ARRA) of 2009 in the amount of \$2,535,006.00, for Ulster County Public Transportation, and

WHEREAS, three projects: the building upgrade, fuel storage and bus purchases have been completed with \$18,909.00 being unexpended, and

WHEREAS, the Director of Ulster County Department of Public Transportation requests that the unexpended funds of \$18,909.00 be reallocated to the automatic vehicle locators project to cover unanticipated system software costs, and

WHEREAS, the Economic Development and Tourism Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it
