Authorizing The Chairman Of The Ulster County Legislature To Execute A Contract With The New York State Department Of Health, Center For Environmental Health To Enforce Adolescent Tobacco Use Prevention Act And The Clean Indoor Air Act – Department Of Health

Referred to: The Health and Personnel Committee (Chairman Aiello and Legislators Belfiglio, Robert Parete, Provenzano and Ronk) and The Ways and Means Committee (Chairman Gerentine and Legislators Gregorius, Harris, Maio, Maloney, Provenzano and Rodriguez)

Chairman of the Health and Personnel Committee, Robert T. Aiello, and Deputy Chairman Jeanette Provenzano offer the following:

WHEREAS, the Commissioner of Health requests that the Chairman of the Ulster County Legislature be authorized to execute a contract (NYS Contract No. C-028544), and any amendments thereto, with the New York State Department of Health (NYSDOH), Center for Environmental Health to provide funds to enforce the Adolescent Tobacco Use Prevention Act and the Clean Indoor Air Act, for the period of April 1, 2013 through March 31, 2018, in the amount of \$326,810.00; and

WHEREAS, the State revenue for the first year of the agreement is in the amount of \$61,362.00 and increases by an additional \$2,000.00 annually; and

WHEREAS, the Ulster County Department of Health will administer these funds utilizing the NYSDOH's Environmental Health Information and Permitting System (eHIPS) to establish and enforce compliance checks for all tobacco retail dealers and vendors according to an established workplan, coordinate program education for new tobacco vendors and those who fail compliance checks, and establish and maintain all Clean Indoor Air Act related complaints, actions, investigations and enforcement; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature be authorized to execute a contract (C-028544) and any amendments thereto, with the NYSDOH, Center for Environmental Health to provide funds to enforce the Adolescent Tobacco Use Prevention Act and the Clean Indoor Air Act, for the period of April 1, 2013 through March 31, 2018, in the form as filed with the Clerk of the Ulster County Legislature or modified with the approval of the County Attorney; and, be it further

RESOLVED, if funding for this program is reduced or eliminated, the program will be eliminated as well,

and moves its adoption.
