WHEREAS, there is broad experience in counties throughout New York with the available range of option for self-governance that may be studied to identify best practices for potential adoption by Ulster County, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with the majority of members voting approval.

RESOLVED, that in accordance with the germane provisions of the Municipal Law of the State of New York, an Ulster County Charter Commission be appointed, and

FURTHER RESOLVED, that at every stage of its work, the commission shall give publicity to its activities throughout the County and make every effort to obtain widespread public comment and input, and

FURTHER RESOLVED, that no later than December, 2005, the Commission make a full report of its recommendations to this Legislature, which report will include a draft document or documents in a form suitable for adoption by Legislative action, and if required by State law, consideration by the public and action at public referendum, and

FURTHER RESOLVED, that in consultation with the Chair of the Commission, appointed in accord with this resolution, two staff persons shall be designated by the Chairman of the Legislature to provide research and administrative support for the Commission's work as part of their assigned duties, and

FURTHER RESOLVED, that the sum of \$50,000.00 is hereby provided to be spent as authorized by the Chair, in accord with regular County procedures, to
