WHEREAS, the Legislative Programs, Education and Community Services Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it

RESOLVED, that the Ulster County Legislature hereby approves Ulster County's 2012 STOP DWI Program Plan, and be it further

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute such intermunicipal agreements, and any amendments thereto, as may be required to carry out the approved Program Plan, as such agreements are filed with the Clerk of the Legislature or as are modified with the approval of the County Attorney,
