WHEREAS, the Commissioner of Ulster County Highways and Bridges has requested \$12,600.00 to process the payment for Engineering Office Supplies, Gas System Repairs, Crane Inspections, Building Alarm and Copier Service Contracts, and

WHEREAS, the Ulster County Legislature transferred approximately 67% or \$25,500.00 of such funds into a contingency reserve to be reallocated to Ulster County Highways and Bridges upon request with sufficient justification for departmental needs, and

WHEREAS, the Commissioner of Ulster County Highways and Bridges requests that the \$12,600.00 be reinstated and transferred from the Contingent Account to Other Miscellaneous Contractual Expenses to process the payment for Engineering Office Supplies, Gas System Repairs, Crane Inspections, Building Alarm and Copier Service Contracts, and

WHEREAS, the Public Works Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
