WHEREAS, this resolution has been submitted by the County Executive, and

WHEREAS, negotiations have been underway between Ulster County and the City of Kingston regarding an agreement to succeed the existing agreement pertaining to sales tax, dated January 18, 2006, and

WHEREAS, an acceptable successor agreement has been proposed, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, it is

RESOLVED, that the Ulster County Legislature hereby approves the agreement between the County of Ulster and the City of Kingston providing for the continuation and extension of the Sales Tax Agreement between the municipalities, dated January 18, 2006, for an additional period of five years, commencing March 1, 2011 and ending February 29, 2016, which provides that 11.5% of net sales tax collections shall be allocated to the City and 3% of such net collections shall be allocated to the area of the County outside the City, and the balance of 85.5% of such net collections shall be allocated to the County, as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and be it further

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized and directed to execute the above-mentioned agreement and any other documents necessary to implement it on behalf of the Ulster County Legislature,

and moves its adoption.
