WHEREAS, Resolution No. 189 dated July 20, 2010 authorized the Chairman of the Ulster County Legislature to enter into a Memorandum of Understanding (herein and after known as "MOU"), with the New York State Office of Temporary and Disability Assistance (NYSOTDA) for Core Imaging Services, and

WHEREAS, the intent of this resolution is to correct the purpose of the MOU and its duration, and

WHEREAS, the purpose of the MOU is to define the conditions and responsibilities under which Ulster County will utilize services offered through the NYSOTDA'S statewide Imaging and Enterprise Document Repository Services Contract (I/EDR) and the On-Site Scanning Solution (OSS) developed by NYS, and

WHEREAS, the MOU shall commence upon signature of both parties and continue until written notification occurs from either party to the other; the parties being Ulster County and NYSOTDA, and

WHEREAS, the Chairman of the Ulster County Legislature was previously authorized to enter into the MOU with NYSOTDA for the purpose of utilizing the State's I/EDR, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it
