WHEREAS, in a second election in June 2011 the Benedictine registered nurses again strongly registered their desire for union representation by NYSNA, and

WHEREAS, management persists to date in denying hospital access to NYSNA representatives, and

WHEREAS, Benedictine registered nurses have a fundamental interest in a working environment which supports the recruitment and retention of highly qualified colleagues resulting in quality patient care, and

WHEREAS, Benedictine registered nurses believe a fair and reasonable contract will improve morale and provide a foundation for the development of a healthy labor/management relationship in the workplace, now, therefore, be it

RESOLVED, that we, as members of the Ulster County Legislature strongly reaffirm our support for freedom of association and the right to collective bargaining, and be it further

RESOLVED, that we recognize and respect the fact that HAHV is a major employer in Ulster County, and be it further

RESOLVED, that Benedictine registered nurses by their exemplary practice and commitment to patients play a key and valued role in the health and welfare of many Ulster County residents, and be it further

RESOLVED, that we strongly urge a speedy conclusion to contract negotiations in order to support continued access to quality medical care for members of the Kingston and surrounding Ulster County communities,
