WHEREAS, the Rape Crisis and Sexual Violence Prevention Program provides funds for 24-hour crisis intervention services, counseling, accompaniment services, victim advocacy, development of a community support system, and education about preventing sexual assault, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature be authorized to execute a contract (NYS Comptroller's No. C-026653), and any amendments thereto, with the New York State Department of Health, for the continuation of the Rape Crisis and Sexual Violence Prevention Program for the period July 1, 2010 through June 30, 2015, in the amount of \$55,000.00 for the initial year, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and be it further

RESOLVED, if funding for the program is eliminated, the program will be eliminated as well,
