The Economic Development and Tourism Committee (Chairman Maloney and Legislators Aiello, Frey, Hayes, Sweeney, Terrizzi, Donaldson, Loughran and Rodriguez) offers the following:

WHEREAS, the United States Department of Housing and Urban Development (HUD) and the New York State Office of Community Renewal have promulgated regulations governing the participation in the Community Development Block Grant (CDBG) Program, and

WHEREAS, the Office of Community Renewal (OCR) administers the CDBG Program with funding allocated from HUD, and

WHEREAS, the Office of Community Renewal has indicated the availability of funding due to Hurricane Irene for disaster declared counties in New York as part of the Agricultural and Community Recovery Fund to match farmers' dollars for the purchase of feed for animals and produce from other New York producers to allow the farms operations to continue, and

WHEREAS, Ulster County has been declared a disaster area for Hurricane Irene and farms within the County have been identified as being eligible for funding, and

WHEREAS, due to the emergency nature of the funding, the application is not required to meet the public outreach requirements for the CDBG Program nor obtain the necessary legislative authorizing resolution, and

WHEREAS, in keeping with the emergency nature of the funding, OCR has revised its timeline requiring both approval of contracts and drawdown of funds to be completed prior to December 31, 2011, and

WHEREAS, the County Executive has submitted an application for funding to OCR for the Agricultural and Community Development Recovery Fund, and

WHEREAS, the activities included in the grant application are unlisted with respect to the State Environmental Quality Review Act (Part 617 NYCRR) and are Categorically Excluded under the National Environmental Police Review Act (NEPA) (24CFR 58.35), and
