

**Amending The 2006 Ulster County Budget – Creating a Part-Time, Non-Benefited Position – County Auditor**

The Ways and Means Committee (Chairman Lomita and Legislators Bartels, Berardi, Gregorius, Provenzano, Zimet, Cummings, Gerentine and Noonan) offers the following:

WHEREAS, the County Auditor has instituted changes in methodologies used to audit claims and supporting documentation is being examined in greater detail including compliance with executed contracts, and

WHEREAS, these changes are increasing the amount of time it takes to audit claims for payment and the County Auditor has identified a need for a temporary part-time, non-benefited position to be created to provide assistance with clerical duties, and

WHEREAS, the County Auditor is requesting a trial period of 3 months at 10 hours per week at [\$10.00] \$12.00 per hour, and

WHEREAS, the Personnel Committee has been polled and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
