WHEREAS, the County Executive and Commissioner of Health request that the Chairman of the Ulster County Legislature be authorized to enter into a Permissive Use Agreement with the Town of Saugerties for the use of space two days per month, beginning January 1, 2013, at the Kiwanis Ice Arena at a monthly cost of \$150.00; and
