WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Employment and Training, and

WHEREAS, the Director of the Ulster County Department of Employment and Training (formerly known as the Ulster County Office of Employment and Training) requests that the 2010 Ulster County Budget be amended to accept an additional \$500.00 in funding for the Career Pathways Program from Westchester Community Opportunity Program, Inc., (WestCOP), and

WHEREAS, WestCOP received these funds as the recipient of a Career Pathways grant from the New York State Office of Temporary and Disability Assistance, and

WHEREAS, the Memorandum of Understanding (Contract No. C10-00276), as amended, provides that the Department of Employment and Training will manage the Career Pathways program in Ulster County for the period from February 1, 2009 to January 31, 2011 and that WestCOP will pay the Department of Employment and Training to manage the program during this period, including reimbursement to the Department of Employment and Training for up to \$21,000.00 of the program's operational costs and, with the additional \$500.00 in funding, up to \$67,500.00 for completing performance milestones, and

WHEREAS, the Career Pathways Program will help economically disadvantaged residents of Ulster County from ages sixteen to twenty-four transition from poverty to self-sufficiency by assisting them with their education and work training, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of its members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of its members voting approval, now, therefore, be it
