WHEREAS, the New York State Department of State has entered into a Contract No. 069948, with Ulster County in the amount of \$60,000.00 in State funding with a required \$15,000.00 local match, and

WHEREAS, the Ulster County Planning Board has been working with communities and has engaged an economist to provide market analysis and studies necessary to complete the work included in the grant application, and

WHEREAS, the current contract needs to be extended to allow the completion of the economic study, and

WHEREAS, the Economic Development, Housing, Planning and Transit Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to amend the agreement and any future amendments thereto and, being said Contract No. 069948, in the amount of \$60,000.00, with the New York State Department of State (DOS) to extend the contract period ending March 31, 2009 to March 31, 2010, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
