WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works, and

WHEREAS, the Commissioner of Public Works requests that Capital Project No. 335 be established in the amount of \$534,457.77 for the purchase of computer hardware and software for an Automatic Vehicle Locator System for highway vehicles for the County and several participating County municipalities, including the Towns of Shandaken, Kingston, New Paltz, Shawangunk, Marbletown and Esopus, and the Village of Ellenville, and

WHEREAS, this is a 2008-2009 Local Government Efficiency (LGE) Grant awarded to Ulster County with NYS Contract #C-088884, for the period beginning April 1, 2008 and ending March 31, 2011, for the capital costs of the Ulster County Automatic Vehicle Locator Program for highway vehicles, and

WHEREAS, 90% State funding has been made available in the amount of \$481,012.00 from the New York State Department of State (LGE Program) for the purchase of computer hardware and software for an Automatic Vehicle Locator System for up to 241 highway vehicles, and

WHEREAS, 10% local funding will be apportioned to the County and the several municipalities up to \$53,446.00, depending upon the number of vehicle locators purchased by each participating government, and

WHEREAS, Ulster County's local share of funding will be allocated in the amount of \$42,136.00 for up to 190 highway vehicles and the several other municipalities will be allocated up to \$11,310.00 for 51 vehicles, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of its members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of its members voting approval, now, therefore, be it
