

**Amending Resolution No. 261 Dated December 5, 2011,
Authorizing And Directing Charges Against Various Towns And
The City Of Kingston For Home Relief Costs**

The Ways and Means Committee (Chairman Gerentine and Legislators Bernardo, Frey, Hansut, Harris, Maio, Maloney, Lomita, Provenzano, Rodriguez and Sheeley) and Legislators Shapiro and Gregorius offers the following:

WHEREAS, Subdivision 6 (a) of Section 65 of Social Services Law requires the Commissioner of Social Services to provide Home Relief for local charges residing or found in a town of the County when the town public welfare officer is absent or the town public welfare officer has decided not to grant Home Relief as recommended, and

WHEREAS, Subdivision 6 (b) of Section 65 of Social Services Law further provides that expenditures made pursuant to this Section, subject to State reimbursement, shall be a charge on, and shall be reimbursed to the County by the Towns and the City of Kingston, and

WHEREAS, Resolution No. 261 dated December 5, 2011 authorized the County to charge back \$28,994.47 to the Town of Shandaken on the 2012 town wide tax levy, and

WHEREAS, the Town of Shandaken has now paid the \$28,994.47 in full, and has requested the County Legislature to amend resolution No. 261 to delete such Home Relief charges due to the County from the Town of Shandaken, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it

RESOLVED, that Resolution No. 261 dated December 5, 2011 be amended to reflect the following amounts be levied and assessed upon the taxable real property of the towns in the amounts indicated and when collected, be made payable to the Ulster County Commissioner of Finance as follows:
