WHEREAS, the Environmental and Consumer Affairs Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign an amendment to an agreement with the New York State Department of Agriculture and Markets for the Petroleum Products Quality Testing Program for the period April 1, 2004 through March 31, 2009, as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and
