WHEREAS, the Ulster County Sheriff, after a thorough review, requests that Capital Project No. 357 be established and funded in order to purchase three marked patrol cars with police equipment at \$102,000.00, one SUV with police equipment at \$38,000.00 and one unmarked hybrid SUV at \$21,500.00 for a total cost of \$161,500.00, and

WHEREAS, the vehicles purchased will replace vehicles that have high mileage or have been damaged beyond reasonable repair and have been determined to be unsafe, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it
