

**Authorizing The Chairman Of The Ulster County Legislature To Sign A Memorandum Of Understanding And Any Amendments Thereto, With The United States Marshall Service, For A Program Grant To Fund The Regional Fugitive Task Force - Amending The 2011 Ulster County Budget – Ulster County Sheriff’s Office**

The Law Enforcement and Public Safety Committee (Chairman Jack Hayes, Deputy Chairman Briggs and Legislators Hochberg, Rodriguez, Belfiglio, Ronk and Sweeney) offers the following:

WHEREAS, the United States Marshall Service has federal funds available to be utilized for the investigation and arrest of individuals for whom active state and federal arrest warrants are outstanding, and

WHEREAS, the Ulster County Sheriff’s Office has personnel to conduct such investigations and arrests, and

WHEREAS, the United States Marshall Service has offered to provide a grant to the Ulster County Sheriff in the amount of \$ 5,000.00 to be used for this purpose, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of its members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to sign a Memorandum of Understanding, and any amendments thereto, with the United States Marshall Service for a grant in the amount of \$5,000.00 for the term June 1, 2011 through September 30, 2011, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and, be it further
