WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to enter into a lease agreement with Pine Professional Center, 16 Plattekill Avenue, New Paltz, NY, for offices of the Ulster County Department of Probation located at 124 Main Street, New Paltz, New York, for a term of three (3) years commencing November 1, 2009 through October 31, 2012, at an annual cost of \$18,312.00 for the first year, \$19,228.00 for the second year, and \$19,228.00 for the third year, as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
