

**Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement To Provide The City Of Kingston With Work Crew Supervisor – Department Of Probation**

Legislator Jack Hayes, Chairman of The Law Enforcement and Public Safety Committee and The Governmental Services, Environmental and Administrative Committee (Chairman Roberts and Legislators Belfiglio, Fabiano, Petit, Ronk, Richard Parete, Robert Parete, Rodriguez and Shapiro) offer the following:

WHEREAS, the Director of Probation has requested that the Chairman of the Ulster County Legislature be authorized to execute an agreement with the City of Kingston, whereby Ulster County will provide a supervisor for the City's dedicated work crew for community service for the period from January 1, 2010 to December 31, 2011, and

WHEREAS, the total cost to the County of the services to be provided to the City of Kingston including salaries, benefits and administration costs is \$44,600.00, and

WHEREAS, pursuant to the proposed agreement, the City of Kingston will fully reimburse Ulster County for these costs, and

WHEREAS, the Governmental Services, Environmental and Administrative Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of its members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement, and any amendments thereto, with the City of Kingston, pursuant to which Ulster County will provide a supervisor for the City's dedicated work crew for community service for the period from January 1, 2010 to December 31, 2011, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,

and move its adoption.
