WHEREAS, the New York State Office of Temporary and Disability Assistance (OTDA) has notified the Ulster County Department of Social Services (UCDSS) that \$50,000.00 has being awarded for the continuation of the Safety Net Assistance Project to enable the Department to continue working with the exempt and work-limited Safety Net population, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
