WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement with the New York State Office of Homeland Security for the State Homeland Security Program (SHSP), as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and
