

Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement With The New York State Office Of Homeland Security For FY06 Law Enforcement Terrorism Prevention Program (LETPP) – Amending The 2006 Ulster County Budget – Sheriff’s Office

The Ways and Means Committee (Chairman Lomita and Legislators Bartels, Berardi, Gregorius, Provenzano, Zimet, Cummings, Gerentine and Noonan) offers the following:

WHEREAS, pursuant to Resolution No. 228, dated July 26, 2006, the County of Ulster and the New York State Office of Homeland Security entered into an agreement for the Law Enforcement Terrorism Prevention Program (LETPP, and

WHEREAS, New York State Office of Homeland Security is now awarding Ulster County \$98,400.00 from the FY06 Law Enforcement Terrorism Prevention Program (LETPP) provided by the US Department of Homeland Security’s (DHS) Office of Grants and Training, and

WHEREAS, the Law Enforcement Terrorism Prevention Program (LETPP) would provide Ulster County with \$98,400.00 to support terrorism prevention and preparedness efforts, and

WHEREAS, the application of grant funds will be to provide for Interoperable Communications, Critical Infrastructure/Key Resource Analysis, Law Enforcement Investigation and Operations and Information Sharing and Dissemination, and

WHEREAS, the grant requires no matching County dollars, and

WHEREAS, the Criminal Justice and Safety Committee has been polled and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement with the New York State Office of Homeland Security for the Law Enforcement Terrorism Prevention Program (LETPP), as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and
