WHEREAS, the Ulster County Legislature endorsed the designation of Ulster County as a Greenway Community and membership in the Hudson Valley Greenway by adoption of Resolution No. 133, dated April 11, 2002, and

WHEREAS, grant funds are available for making access to the Sojourner Truth Ulster Landing County Park compliant with the Americans With Disabilities Act (the ADA), and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Ulster County Legislature supports the submittal of an application to the Hudson River Valley Greenway Small Grant program in the amount of \$7,000.00 for construction of an ADA compliant trail at Sojourner Truth Ulster Landing County Park,

and move its adoption.
