WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Planning; and

WHEREAS, New York State Department of Agriculture and Markets has notified Ulster County that Agricultural District No. 1 in the Towns of Esopus, Lloyd, New Paltz, Plattekill and Marlborough is approaching its eight-year anniversary date of July 21, 2013; and

WHEREAS, Agriculture and Markets Law Article 25AA requires the County to cause a review of the District to be conducted and completed within 300 days; and

WHEREAS, Agriculture and Markets Law Article 25AA requires a Public Hearing to be held between day 120 and day 180 of the 300 day review period of the district and any proposed modifications to the district; now, therefore, be it

RESOLVED, that the Chair of the Legislature is authorized to call such Public Hearing no sooner than January 22, 2013 and no later than March 23, 2013; and be it further

RESOLVED, that the Clerk of the Ulster County Legislature is hereby directed to cause a legal notice of said Public Hearing to be published according to law; and be it further

RESOLVED, that the Clerk of the Ulster County Legislature is hereby directed to provide in writing to all affected municipalities a copy of the hearing notice,

and moves its adoption.
