WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Board of Elections, and

WHEREAS, the New York State Board of Elections has allocated certain state funds provided to New York State to Ulster County to improve access to polling places in the amount of \$8,855.00 as part of the New York State Budget for FY 2009-2010, and

WHEREAS, the Commissioners of the Ulster County Board of Elections have requested that the Chairman of the Ulster County Legislature be authorized to execute a contract (Contract No.T003006), and any amendments thereto, for the period August 1, 2009 through July 31, 2014, in the amount of \$8,855.00 funding from the NYS budget for fiscal year 2009-2010, with the New York State Board of Elections, to receive the allocated funds for the New York State Voting Access for Individuals with Disabilities – Polling Place Access Improvement, and

WHEREAS, the purpose of the allocated funds is to establish, expand and improve access to polling places and participation by individuals with a full range of disabilities in the election process, and

WHEREAS, the New York State Board of Elections Contract will be administered over a five year period, beginning August 1, 2009 and shall terminate on July 31, 2014, and

WHEREAS, the Governmental Services, Environmental, and Administrative Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute Contract No. T003006 and any amendments thereto, with the New York State Board of Elections, to receive the allocated funds for the New York
