

**Authorizing The Chairman Of The Ulster County Legislature To Enter Into Agreements With Various Municipalities For Supplying Ulster County With Information and Data Concerning DWI Cases In 2010 – Ulster County STOP DWI**

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Briggs, Richard Parete, Zimet, Hansut, Maloney and Ronk) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County STOP DWI, and

WHEREAS, Ulster County desires to collect information and data concerning the disposition, during the 2010 calendar year, of DWI and DWAI cases handled by the various Towns, and

WHEREAS, to compensate these municipalities for collecting and supplying Ulster County with this data and information, Ulster County will, upon adoption of this resolution, enter into agreements to pay to various municipalities, \$10.00 (Ten & 00/100 Dollars) for information and data related to the disposition of each DWI or DWAI charge it processes, and

WHEREAS, this data and information is used by Ulster County STOP DWI to comply with Section 1197 of New York State Vehicle and Traffic law, and

WHEREAS, the amount paid to the various municipalities by Ulster County for this data and information collection will not exceed \$10,000.00 (Ten thousand and 00/100 Dollars) in the aggregate, and

WHEREAS, the STOP DWI Advisory Board has met and reviewed this request and recommends funding this information and data collection for 2010, with a majority of the members voting approval, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that in order to provide payments to various municipalities within Ulster County, for DWI and DWAI information and data collection, the Chairman of the Ulster County Legislature is hereby authorized to enter into agreements with such municipalities, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
