WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Health, and

WHEREAS, the Acting Public Health Director requests that the Chairman of the Ulster County Legislature be authorized to execute a Contract (Contract No. C024223) and any amendments to the Contract with the New York State Department of Health to renew the Lyme and other Tick Borne Disease Education and Prevention Program, for the period April 1, 2009 through March 31, 2012, (funding for the period 4/1/09-3/31/10 is \$20,000 - future funding to be determined), and

WHEREAS, funds will be used to maintain and/or enhance outreach efforts: school and community groups will be targeted for presentations, continued education of County residents and visitors will be provided through mass media, including press releases and paid radio ads, and there will be a focus on professional development efforts, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature be authorized to execute a Contract (Contract No. C024223) and any future amendments thereto, with the New York State Department of Health to renew the Lyme Disease Education and Awareness Program, for the period April 1, 2009 through March 31, 2012, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and, be it further

RESOLVED, that if funding for this program is eliminated, the program will be eliminated as well,
