WHEREAS, the grant will be administered through the Ulster County Planning Board, partnering with non-profit housing providers, and

WHEREAS, the Economic Development, Housing, Planning and Transit Committee has been polled and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is authorized to execute contracts and agreements with the Governor's Office of Small Cities and sub-recipients of the funding, in a form as filed or may be filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney as necessary to carry out the program and projects as provided for in the grant award including amendments, and

FURTHER RESOLVED, the Chairman of the Ulster County Legislature is authorized to act as certifying officer with regard to grant administration documents
